**Fort Lauderdale Fire Rescue Battalion Chief Jermaine Frazier, Captain Lesly St Fleur and CERT's Mark Miller** gave a presentation on the role and activities of CERT (Community Emergency Response Team). They announced the next training session will be held on Sat., April 22 & 29 (must attend both days). Those in attendance who have been involved in CERT strongly recommended it to the group and encouraged neighborhoods to support their neighbors joining. CERT will be happy to make presentations at any neighborhood association meeting. They will also teach 1 hour hands-only CPR course at any meeting.

**Reports:**

**Bill James, CFLCA District 4 Rep** gave an update on SB188 and HB425 Vacation Rentals, which are working their way through the legislature and our efforts in opposition to same. Bill James is our lead/point person on this. He gave a brief history/overview on the legislation. The new bill would prohibit all regulation of short-term rentals by a municipality unless it had something in place prior to the 2011 legislation. There was a lot of discussion and for those opposed, it is strongly encouraged to take action immediately. **Steve Buckingham** updated on the Medical Marijuana Ordinance. Recommendation for final regulations, which includes some of our recommendations, will be presented to Planning and Zoning at their meeting next week.
