 - o Chris Lagerbloom, City Manager, City of Fort Lauderdale-
 - Hiring program manager 2nd round interviews 11/12/2019 to make sure plans operating from make sense today and not stale.
 - Working w/ realtors to id parcels that fit 10min walk criteria and looking at vacant/desirable 8 parcels in progress now.
 - EMS Substation: couple parcels looking @ S of river w/ LOI and waiting on both before take to commission very different. The more expensive one there is a strong argument business why for more expensive one.
 - o Phil Thornburg, Director, Parks and Recreation, City of Fort Lauderdale-
 - Program Manager hire to implement bond on behalf of City outreach all the way to bidding, project managers, to opening. Project Manager will be hired City Staff member only job to supervise Program Manager. Aim early 2020 to be moving on this.

QUESTIONS FROM CFLCA MEMBERS ON PARKS BOND TOPIC FOR LAGERBLOOM/THORNBURG OVERVIEW Q'S: LAGERBLOOM TAKES UP HERE

- 1. The "list" that was used to support the need for the bond was about 30 pages and described as a living breathing document by some members of the Commission. What is the status of that initial list today? List was part of bond resolution so no bait and switch but some level of flexibility exists. \$30million/4 districts for projects not identified @ time of resolution and \$ set aside for land acquisitions.
- 2. When can associations begin scheduling neighborhood feedback meetings on parks bonds improvements? Expect beginning of 2020 but hiring needs to be done.
- a. Will that be done by staff or by a hired firm? See P.T. remarks.

- 3. How will projects be prioritized? Working in a way that's mindful of all districts. a. Will you consider how long it has been since a neighborhood has received parks improvements in any form? Not sure that catapults you to top of list. b. As of now what parks do you anticipate will receive funding 1st for improvements? c. What is the right process for achieving neighborhood specific needs? Sometimes it appears some neighborhoods are getting more than their fair share. Iconic projects will start soon but project management team is going to deal w/ "low hanging fruit" and will have to be ongoing balance to make sure across board done.
- 4. What is the process for determining purchases of land? 10 min. walk accepting suggestions and also see above.
- 5. How much has been spent already? Small amount because will need reimbursement out of general fund. Likely District 1 will be first around \$2.4 if commission decides to buy.
- 6. Can this money be used for anything other than the purchase of land for parks and improvements to parks? Need direct nexus to parks
- a. Is a neighborhood entranceway an area where this money will be spent? Stretch need nexus never considered this as a park before
- b. How about entrances to the City? Stretch need nexus
- 7. With regards to oversight, will that be a task of the Parks & Rec. Board or a new board? Parks and Recs.
- 8. Will we outsource the implementation of the bond funds or hire more staff? Outsource implementation so far is the plan. Staff doesn't have power to spend that much money as quickly as needed.
- a. Customer Service will need to be a focus for the parks bonds initiatives. Is there thought or guidance on what customer service processes or metrics will look like for parks bonds projects? City staff won't be doing this so it will not take from their ability to provide level of service.
- 9. Will 80 percent of the bond monies be invested back into the city foundation? (Parks) needed clarification but not obtained
- 10. How much of the bond funds will be use for consulting fees? Don't know yet it will be negotiated was an RFP
- 11. How much of the bond funds will be used for studies? Need to make sure parks M.P. is still good money need to design and build could consider this a study but don't plan on doing new M.P. and study for years etc.

MORE SPECIFIC TO DISTRICTS

- 12. Feedback on their assessment of the ULI Panel findings/recommendations. C.L. opinion not a fan b/c advanced position of DDA and top 3 weren't even things DDA does City would have to do.
- 13. Inclusion of an update on Holiday Park plans. Does the contract with the Panther's reduce the amount proposed to be needed for updates? Does not Panthers is all in War Memorial and footprint right next to it.
- 14. How much money will be invested in Sistrunk's or Northwest Parks? Even across districts. Carter is identified as major investment over there per McKinzie
- 15. Provide an update on Tunnel Top park. Maximize capacity so looking for max distance can be on the North side note 11/25 feedback date above. FDOT does study and decides how big can be.
- 16. How much of this money will be spent on city owned sea walls? Don't know answer but only sea walls that are supporting parks.
- 17. Will funds from the parks bond be designated regular maintenance of the following at/near Fort Lauderdale beach:
- a. our beach wall, including the led lighting in the wall no already funded in budget as recurring maint. cost
- b. New oceanfront plaza- some parks bonds fund may be used but there are multiple sources that will be used via eligibility and budgeting process
- c. The restrooms/fountains/showers/tables/grills at the South lot- more park maintenance than bonds funds

Communication: is there an updated list and how will city update residents?

- Join board's by visiting City Clerk's website.
- Matrix will be used to determine order of projects
- Communication is important but always concerned with overdoing it. Will require a public communication plan from consultant
- Garages cost-\$25k/parking space to calculate
- Properties in process- keeping it quiet aids with negotiation benefit because if everyone knows
 City is shopping costs go up.
- small park = quick win
- city is will to consider ULI recommendation of repurposing water
- tree canopy is important has increased over last several years
- neighborhood density being considered when determining if a park is needed as well as future growth

- debt not issued so no interest yet as of today las olas/a1a park has not been funded via any park bond \$.
- One Stop Shop status- in process of sod/irrigation, GSA looking at for new Federal building,
- Does city have money to maintain as move forward? In future years will need to fund that
 - Some parks will require additional staff to run recognize more than build cost
