Thank you for the updates Christina and Colleen!

I just spoke to Sun Trust on the phone about our CD renewal. The rate that it is currently renewing at is very poor-- **.10%** . I have seen this happen before with good promotional rates at large banks--they default to auto-renewing at a non-competitive rate. She could not give me any other offers and I would not be able to discuss the account in person at the branch yet due to not being a signer.

My suggestion based on this information is that the board vote to NOT renew this particular CD with Sun Trust. Colleen, you or Bruce will then have to accompany into a branch to get this auto-renewal canceled this week (no later than end of day Friday). It cannot be done on the phone, unfortunately. I would prefer to present some more competitive rate options to the Board at a meeting in the immediate future.
