The United States General Services Administration (GSA) has expanded its site selection search for the construction and design of a new federal courthouse in Fort Lauderdale, Florida. The GSA appreciates the feedback and participation from attendees of the Public Scoping Meeting conducted on 2/18/2020. The GSA has taken your feedback into consideration and is no longer considering the three sites that were presented at this meeting.

This correspondence is to inform interested parties that the GSA has broadened the parameters of its search to consider offered sites ranging from 1.5 - 5 acres within the boundary of the Fort Lauderdale City Limits. The GSA explored other options, such as meeting with the City, County, Downtown Development Authority and sent out Request for Expression of Interest via public notice, in order to identify any potential sites. Based on the feedback, GSA is considering the following four sites:
