**GUEST COMMISSIONER BEN SORENSEN- CONVERSATION.**

- **COVID-19 approaching from 12 year military experience/decision making data driven and risk adverse/preventative & aggressive in this manner.**
  - 375000COVID19 worldwide 16000 deaths 42700 cases US 519 deaths
  - Florida 171 cases 14 deaths 258 cases in broward
  - We do not have hospital capacity to sustain significantly increasing pandemic.
  - State/fed resources coming in to help address what experts say is increasing case load
  - Ben perspective need to be aggressive/progressive
    - City needs to be doing more has been/continues to ask for more aggressive
    - Has asked/continues to: 1) week by week safer @ home directive, 2) week by week prohibit pub/priv gathering on/off water, 3) facilitate respite for 1<sup>st</sup> responders 11pm – 5am exceptions essential businesses/employees 4) any gathering no numerical limits but a family is not considered a gathering 4) closing of all but essential business, major infrastructure and similar constructions are essential where furthers safety of residents/project/etc.
      - Luis wants pet store to be included as essential. Can we follow what FDOT is doing? Managers enforce social distance.
    - FLPD cannot enforce that everyone abides and arrest is not intention. Intention is majority will abide & peer pressure will discourage ignoring directive.
    - Next couple weeks are critical per doctors Ben speaking to.
  - If agree encourage all we interact with to stay @ home.
  - Q's:
    - Colleen: 15day White House & City ends @ 4/16. Is it fair to say we will make decision around 4/16 to decide how/if to extend? Yes, as closer to point will be making decision as to what to make and b/c of fluidity decisions can me made sooner. Ben advocating for a while web/phone City meetings and 4/7 will be kickoff for video conference City commission meeting. As this new method rolls out we can move quicker.(Ben shared with colleagues on Friday not much support continues to tell Lagerbloom)
    - Ben is advocating for safer at home as soon as possible.
    - Specific issues on individual basis and causing struggles about where to go as far as process.
    - Mary: Coral Ridge (& at beach) Air BNB/spring breakers is there any way to close the vacation rentals? Mary agrees w/Ben plan. Miami Beach just shut down hotels/vacation rentals and is within authority of City and Ben thinks we should. Mary agrees again.

- Luis agrees with Mary & asks how do vacation rentals get closed. Due to emergency power City has authority force vacation rentals to close/vacate. CMC follow-up Ben reiterates no authority now and contact will be via government actor.
  - Melinda: Mayor/Commission protocol in decision making @ this point and how do we get this to happen? Ben 1) sunshine law applies even in state of emergency 2) how can this happen/how do decision happens? Who has power to update/change mayor directive (ben asked) City Attorney mayor can update at any time and city commission via city manager can ask for commission meeting to do the same. Per Lagerbloom, If 3 commissioner say want to update City Manager will call public meeting for that to be discussed. Ben hopes for Mayor update or for other colleagues to join in. Finer point: Ben cannot advocate for changes/update however- residents can. Governer/President hasn't issued statewide. UK has 6650 case vs US 42721.
  - Colleen: airbnb is not public gathering. As directive is no you cannot address unless over 10 people and capacity for sleeping is less than 10 could technically tell them to leave.
  - Albetta: beach congregating on wall of beach groups 20+ 3/22 530 to 630pm. Ben response No public or public gatherings on water of land is what Ben thinks is needed.
    - Colleen raises beach a1a again. Can 6foot be part of directive? Yes. Would still allow people to do outdoor exercise but aim is to discourage commuting. Closing A1A not good for emergency reasons and don't want to encourage coming to beach.
  - Colleen: what can we do as community so as not to duplicate City communication taking out to community? Stay @ Home is most important thing to share. Be risk adverse. Special care vulnerable populations/neighbors and awareness.
    - "google sheet" for people to share feedback/tips.
  - Colleen: Is city purchasing any tool and can it be for associations? Ben has requested zoom account to talk to neighbors and Lagerbloom authorized for all commissioners to buy and City will reimburse. \$150/year around 100 people and Ben will share.
  - Jim: discussion on more restrictive access to grocery as in other countries (max # @ time being enforced & spreading in line) no discussion yet and really become a matter of private property enforcement. Concannon will get resources from BG
- Ben closing/creating google sheet to share ideas/q's and Ben will share. Colleen would be open to that.
  - Neighborhood support who is monitoring and would like to work on feedback collection. Juan/Ben to do.

## Commissioner:

Although there is no prohibition against the City reiterating or otherwise noticing its Declaration within a condominium through posters or notices, our Declaration's 10-person rule pertains to "public gatherings," and wouldn't apply to or be enforceable against residential and common areas in condominiums. Condominiums, even common areas, just like single-family homes, are tricky to regulate under these circumstances.

Ben/Melinda/Chris,

Thanks for your work during the pandemic. I was forwarded the email below and want to make a suggestion re: Condos/social distancing and a possible City response.

It is important for neighborhood leaders (in this case condo boards) to feel they have the support of the City Officials in executing the terms of the City emergency order.

Suggestion:

The City could provide a correspondence to each Board and a poster size Notice to each condo to prominently post on property which features the most relevant excerpts of the emergency order which I see as the following:

- 2) prohibition on group gatherings of 10+
- 3) prohibition on operation of entertainment facilities within an enclosed structure
- 4) prohibition on operation of fitness facilities with capacity of over 10 which are amenity of residential building.

The end date should be listed in a manner which can be easily edited when/if the regulations are extended.

Some people maybe willing to comply if the instructions come from the governmental entity and not folks they may perceive as "condo commandos." Some will still feel inclined to ignore but this correspondence may empower Boards to lock an entertainment room or fitness center/pool area with a capacity of over ten.

I realize there are many condos in FTL and this is more than 1 or 2 notices. You could also do a webbased PSA geared to condos to accompany the notices to show that City officials are working to educate/assist this group of residents.

It is not easy being a neighborhood leader and even the smallest amount of relief is appreciated by these volunteers!

Hi Ben-  
Thanks for your response to Mike.

I am 100% in agreement with you both on the urgency of needing a shelter-in-place order.

Mike-thanks for sharing the challenges you have had in the WaterGarden as I am experiencing the exact same thing in NuRiver Landing. We have 423 units---over 800 residents (100 dogs :-))

Downtown we have a lot of concentrated large multi-family residential buildings that are basically small cities/cruise ships without a canteen. Due to the shared elevators, mailrooms, and common areas--they provide a lot potential hubs for spreading this disease. Some of these buildings have large concentrations of residents over 60. Guests continue to visit some, use the pool, gym, etc. The beach is in a similar situation.

Due to the governance structure of our associations, board members right now are doing their best to make choices that are going to impact the health of everyone in our communities. This is still generally occurring at virtual board meetings. Some board members are absolutely being attacked for espousing conservative and safe guidelines, like closing all common areas. There are board members in these communities who will unfortunately be swayed by the loudest and most ill-informed that want to keep facilities open for selfish reasons. As in some governance situations, the loudest few can cause a silent or unaware majority to suffer.

I am in support of a shelter-in-place being order by City, County, and State. I hope it will happen soon.

Thanks so much for your feedback and I am sorry this has led to some really difficult interactions. I agree with you about the need to issue shelter in place orders. However for the time being, our emergency order stipulates that common space in residential condos such as gyms and pools can remain open as long as there are no more than 10 people in these areas at a time and that social distancing is occurring.

Ben, for what it's worth, the city measures have put a number of us who serve on condo boards in a very bad position (specifically, the exception, without any recommendations, for residential buildings).



Some board members promote letting people do essentially whatever they want with common elements (gym/pool) regardless of what it means in terms of potential disease spread (or requiring redirection of resources for additional cleanings of these areas that could be used on essential areas such as elevators). Others (like me) have pushed for all reasonable steps to minimize risk to residents and closing common areas to the extent possible.

Undoubtedly this has led to arguments (to put it mildly) in every condo association and abusive comments towards board members doing their best to protect people. Going forward, it would be really helpful if authorities (city, county, state, health department, etc.) could provide clear guidance or recommendations on what we should do to reasonably protect people.

Interestingly, we have received pushback from some of our most at-risk people. Truly bizarre.

Any thoughts or help that could be provided, particularly if we move to a “shelter-in-place” order, would be really helpful. If that happens, I can’t imagine having common areas open in large buildings where people can gather. There will always be some people who don’t care or won’t comply with reasonable requests.
