Tips from Nik Harris & committee meet/compile. Marilyn suggests that tie more to mission statement of CFLCA how about improve quality of life/why inclusiveness matters/helps. Mary why does this only refer to suggestion that should be CFLCA as a whole not Board b/c not relative to Board recruitment. Marilyn mission is to and being inclusive/keep in mind helps recommendation of removal of recruitment language. Mary HR history "worries" about this and wants it run by an attorney/risk of "shooting in foot." Mary Reference to organizations who don't have & wants to hear Nik Harris 1<sup>st</sup> for clarity. Jim what's goal of this who does it go to

and how does it relate to CFLCA and where does it go. Goal to lead by example and statement is an example of that. Reference on website and guides CFLCA Marilyn is concerned b/c CFLCA doesn't get to pick members. Luis finds this statement can be married to purpose and idea is if we don't' have body representative of "everything" this could encourage a more diverse composition. Marilyn continues to express concern of forcing on people. Colleen says position statement begs the question why now? Response is reference to recent discussions on equality/race and spell out atleast 1-2 more sentences on racial equality. Timing inquiry-racism, city national news/protests, sexual orientation remarks made by public officials recent/past. Discussion on choice remarks/intent rec. to lean into race angle b/c universal. Currie comments on focus mostly negative comments and this is about where we want to go and who we want to be and reminder to think of how dialogue of CFLCA has changed in past year equity/race/affordable housing/perspectives/etc. Colleen suggests hold til Nik then maybe add 2 reframe not Board and putting action behind it. Stubbs things take out recruit/board it's just start sentence @ "We welcome" (also sentence 2) Melinda agrees with Stubbs and thinks many ways to further & if can connect to associations that increases diversity. Melinda further adds Consider nom. Committee/bylaws ways to help encourage involvement from broader environment. Jim not about board it is about community/CFLCA move forward but wait until after Nik Harris conversation, tweek, move forward and expresses all feels we all share. Revisit April 2021

The Council may request interim audits at any time. The audit results shall be reported at the May meeting or at the next meeting of The Council following the audit."

4. D&O Insurance update- Melinda 2/23/2021 will have quote for basic policy non profit d&o \$1mil/claim in aggregate. Jim references to his HOA coverage \$2200/year approx. Inquiry into defamation, cyber liability, 1<sup>st</sup> cost, explanation of counsel costs coverage is it organization or each sep. member, etc. Jim has asked for CFLCA BOD coverage quote & Melinda will reference w/ seller.
