

The Council of Fort Lauderdale Civic Associations, Inc General Membership Meeting Minutes – April 9, 2024

The meeting was called to order at Fire Station two, 528 NW 2nd Street, Fort Lauderdale, Florida, at 6:32 P.M. by Council President, Mary Peloquin.

PLEDGE OF ALLEGIENCE AND ROLL CALL

1. SPEAKERS

- a. **Fort Lauderdale Police Officers** No report. The officers were unavailable during the time of our meeting.
- b. Proposed Noise Ordinance Anthony Fajardo, Assistant City Manager, Porshia Garcia-Deputy Director Development Services, Katrina Jordan, Code Compliance Manager. Mr. Fajardo was out of town., The presentation was given by Porshia Garcia and Katrina Jordan. The City Commission formed a Noise Committee two years ago to look at possible revision to the noise ordinance related to noise from the entertainment districts, etc. There is no proposed draft ordinance at this time. Discussion centered on noise decibel readings. The Committee is working with a consultant and they are looking at taking noise measurements in the entertainment disricts at a different location from the establishments that are generating noise then is currently being done. There was a question and answer session. More information will be provided to us in June and a proposed ordinance will then be presented to the City Commission for adoption.

- c. Proposed Trash Ordinance -Tom Andrew-Riverside Park Board Board Member- Mr. Andrew presented a presentation on trash in and around dumpsters and dumpster enclosures. There are unsanitary, unhealthy, conditions of medical wastes, trash, garbage, diapers, etc. in and around dumpsters and dumpster enclosures. These conditions also attract rodents and insects. There needs to be a priority on this problem with resolution and action. Council Board Member, William Brown, offered to work with Mr. Andrew on this important issue and report back to the Council.
- d. Community Court Volunteer Lunches Lin Morgan, representative of South Middle River Civic Association Lin Morgan started the volunteer lunch program 2 years ago and over 700 lunches have been served at the Community Court. Also attending with Lin, was Marie Joeph, City of Fort Lauderdale Neighbor Support. The Community Court is held every Wednesday from 9 AM until Noon.
