

The Council of Fort Lauderdale Civic Associations, Inc General Membership Meeting Minutes – May 14th, 2024

The meeting was called to order at Fire Station two, 528 NW 2nd Street, Fort Lauderdale, Florida, at 6:34 P.M. by Council President, Mary Peloquin. This meeting was a hybrid meeting taking place in person and on Zoom.

PLEDGE OF ALLEGIENCE

1. SPEAKERS

- a. Thank you to City Manager Greg Chavarria Mr. Chavarria could not attend in person, but participated via Zoom from his car. President Peloquin thanked Mr. Chavarria for his service to our city as City Manager and presented Mr. Chavarria with an equestrian ribbon. Mr. Chavarria said he would attend the June 11 Council Meeting in person to shake hands with everyone.
- b. Welcome to Interim City Manager Susan Grant. Mrs. Grant stated under our City Charter, her title is Acting City Manager. Mrs. Grant gave her educational background, she was previously employed by the City of Coral Springs for 27 years in various roles, and was employed by the City of Fort Lauderdale since 2019 as Director of Finance In July 2022, Mrs. Grant was promoted to Assistant City Manager, and was now named the Acting City Manager by the City Commission.

b Mrs. Grant announced that Assistant City Manager Anthony Fajardo, would be joined by Acting Assistant City Manager, Laura Reece, who was promoted from Director of the Office of Management and Budget, and Acting Assistant City Manager, Ben Rogers, who was promoted from Director of the Transportation and Mobility Department. Mrs. Grant stated she is looking forward to her service as Acting City Manager and working with all of us in the neighborhoods and Council. Mrs. Grant announced the city commission would form an advisory committee to assist in the search for a permanent city manager. President Peloquin stated the Council would like to have a representative on the committee. Mrs. Grant was also presented an equestrian ribbon by President Peloquin.

- c. Added to the Agenda, Fort Lauderdale Police Officers Report Sgt. Reich gave a report and mentioned the recent non- profit benefit fund raising effort at community restaurants had raised the 4th largest amount of any law enforcement agency in the state. Sgt Reich stated he would give email addresses for the other city PD Support Teams to President Peloquin to distribute to the Council members and that the PD was open to any events etc. that associations wanted to do with the PD to engage with the neighborhood associations. Mr. Ulmer mentioned that it was National Police Week. That we thank our law enforcement and remember those who gave their all in service to our city.
- **d. City Hall Re-Imagined** Laura Reese, Fort Lauderdale Budget Director and Sheryl Dickey, CEO Dickey Consulting Services, Presented an overview of the five city workshops on Re-Imagining City Hall along with a report from Marilyn Mammano, Chair of the Infrastructure Task Force Advisory Committee.
